


Saya amat berbesar hati untuk membentangkan Laporan Kualiti Alam Sekeliling 2015 seperti yang dikehendaki di bawah Seksyen 3(1)(i) Akta Kualiti Alam Sekeliling 1974.

Jerebu merentas sempadan telah mengakibatkan Malaysia, diselubungi jerubu daripada bulan Ogos 2015 hingga Oktober 2015. Episod jerubu kali ini adalah antara yang terburuk semenjak tahun 1997. Pada 4 Oktober 2015, Shah Alam telah mengalami IPU paras Berbahaya (IPU melebihi 300). Episod jerubu ini juga telah menjejaskan kelancaran persekolahan dengan penutupan 7645 buah sekolah dalam tempoh dua bulan tersebut.

It is my pleasure to present the Environmental Quality Report 2015 as required under Section 3(1)(i) of the Environmental Quality Act 1974.

Malaysia was blanketed by trans-boundary haze from August, 2015 until end of October 2015. This haze episode is one of the worst since its inception in 1997. Shah Alam experienced Dangerous level API (API more than 300) on 4th October 2015. These haze episode also had caused 7645 schools closed in this two months period.



Kualiti persekitaran marin kawasan pantai, kuala dan pulau menunjukkan kemerosotan pada tahun 2015. Tren Status Kualiti Air Marin Kawasan Pantai menunjukkan Bilangan stesen Terbaik menurun daripada tiga puluh (30) stesen pada tahun 2014 kepada Sembilan (9) stesen pada tahun 2015. Manakala bagi stesen Tercemar menunjukkan peningkatan daripada sifar (0) stesen pada tahun 2014 kepada dua (2) stesen pada tahun 2015.

The quality of the marine environment with respect to coastal, estuarine and island areas has reduced in year 2015. The trend of Marine Water Quality for Coastal Area shows that numbers of stations in Excellent category have decreased from thirty (30) stations in year 2014 to nine (9) stations in year 2015. Meanwhile stations under Polluted category have increased from nil (0) in year 2014 to two (2) stations in year 2015.

Sementara itu kualiti air sungai telah menunjukkan peningkatan pada tahun 2015, di mana peratus bilangan sungai yang dikategorikan sebagai bersih telah meningkat kepada 58% pada tahun 2015 berbanding 52% berbanding tahun 2014. Peratus bilangan sungai yang dikategorikan sebagai tercemar telah menurun daripada 9% pada tahun 2014 kepada 7% pada tahun 2015.

On contrary, river water quality has increased in year 2015, where the percentage of clean rivers has increased to 58% in year 2015 compared to 52% in year 2014. Meanwhile the percentage of polluted rivers has decreased from 9% in year 2014 to 7% in year 2015.
