A CRIME IS AN OFFENCE AGAINST  
THE STATE THAT CARRIES A  
PENALTY

## CATEGORIES OF CRIMES

- Ordinary Crimes.
- Strict Liability Offence.

## Ordinary Crimes

There are 2 aspects in an ordinary crime:

- ***Actus Reus***
  - Commission of an act
  - Omission of an act
- ***Mens Rea***
  - Intention
  - Knowledge

### MAXIM:

***ACTUS NON FACIT REUM NISI MENS SIT REA***

An act does not make a man guilty unless he has  
a guilty mind

## Strict Liability Offence

- The commission of an offence by the mere actus rea
- No mens rea required
- E.g. parking offences

## TYPES OF CRIMES

- Bodily Injuries
- Sexual Offences
- Property Crimes
- Psychological crimes
- Cyber crimes
- Commercial Crimes
- Crimes against Sovereign Ruler / Country
- Media Crimes
- Terrorism Crimes
- Crimes against good name / standing
- Contempt of a Lawful authority
- Others

## PAX INCAPACITA

- Insane person / unsoundness of the mind
- Children of 10 years of age and below
- Disability
- Under duress
- Others

## CRIMINAL LIABILITY

- Age of 10 and below – total absolution
- Between 10 –12 – dependent on ability to understand the right from wrong
- Above 12 – 18 culpable for crimes committed but may not suffer the same penalty
- 18 – 21 culpable but has mitigation by age
- above 21, total culpability and suffrage of penalty
