

SYARAT-SYARAT PENCALONAN

1. Calon individu mestilah **berwarganegara Malaysia** yang **berumur 18 tahun dan ke atas**.
2. Pencalonan kategori organisasi terbahagi kepada empat (4) kumpulan iaitu Agensi Kerajaan, Swasta/Industri, NGO/Komuniti dan Institut Pengajian Tinggi.
3. Organisasi yang dicalonkan hendaklah yang **berdaftar atau ditubuhkan di Malaysia**.
4. Pencalonan hendaklah disertakan dengan **surat sokongan** untuk rujukan.
5. Calon hendaklah telah memberi sumbangan yang signifikan ke arah mempertingkatkan kesejahteraan alam sekitar dan kualiti hidup rakyat dari segi impak dan kos sama ada dalam bidang yang spesifik atau kombinasi bidang-bidang yang berkaitan dengan alam sekitar selaras dengan Deklarasi Langkawi seperti:
 - *Corporate Social Responsibility (CSR)*
 - *Conservation, Education, Promotion and Awareness (CEPA)*
 - *Biodiversity*
 - *Climate Change*
 - *Carbon Footprint*
 - *Waste Management*
 - *Community Outreach*
 - *Green Court*
 - *Integrated River Basin Management*
 - *Best Practice Management in Agriculture*
 - *Sustainable Forestry Management*
 - *Rain Harvesting Technology*
 - Bidang-bidang lain yang berkaitan.
6. Sumbangan terkini calon individu/organisasi akan diberikan keutamaan dalam proses penilaian anugerah.
7. Individu/organisasi yang telah menang tidak boleh dicalonkan semula dalam tempoh lima (5) tahun.
8. Individu/organisasi yang dicalonkan hendaklah tidak disabitkan dengan tindakan undang-undang di bawah Akta Kualiti Alam Sekeliling 1974 atau lain-lain tindakan undang-undang dalam tempoh pencalonan.

9. Pencalonan hendaklah menggunakan Borang Pencalonan yang telah disediakan oleh Jabatan Alam Sekitar.
10. Individu yang dicalonkan hendaklah mengepilkan satu **salinan kad pengenalan** beserta **gambar terkini berukuran passport** manakala bagi organisasi yang dicalonkan hendaklah mengepilkan **salinan sijil pendaftaran pertubuhan (kecuali daripada kumpulan agensi kerajaan)** yang **disahkan**.
11. Borang yang lengkap dan mematuhi syarat-syarat pencalonan perlu dialamatkan dan sampai kepada Urus Setia Anugerah Langkawi - Kelestarian Alam Sekitar, Jabatan Alam Sekitar (seperti alamat di bawah) sebelum atau pada tarikh tutup yang telah ditetapkan. Bukti penghantaran pos tidak boleh dijadikan sebagai bukti penerimaan.
12. Sebarang keputusan adalah muktamad. Pihak pengajur berhak menarik balik penganugerahan sekiranya terdapat alasan yang munasabah untuk berbuat demikian.

NOMINATION CONDITIONS

1. Individual candidates must be a **Malaysian citizen aged 18 and above**.
2. The nomination of the category of organization is divided into four (4) groups namely Government Agency, Private/Industry Sector, NGO/Community and Institute of Higher Education.
3. Nominated organizations must be **registered or established in Malaysia**.
4. Nominations must be accompanied by a **supporting letter** for reference.
5. Candidates should have excellent significant contributions towards enhancing the well-being of the environment and the life quality of people in terms of impact and cost either in a specific field or combination of areas related to the environment in accordance with the Langkawi Declaration such as:
 - Corporate Social Responsibility (CSR)
 - Conservation, Education, Promotion and Awareness (CEPA)
 - Biodiversity
 - Climate Change
 - Carbon Footprint
 - Waste Management
 - Community Outreach
 - Green Court
 - Integrated River Basin Management
 - Best Practice Management in Agriculture
 - Sustainable Forestry Management
 - Rain Harvesting Technology
 - Other relevant fields
6. Priority in the awarding process shall be given to the latest contribution of individual/organization.
7. The individuals/organizations that has been awarded is ineligible to be re-nominated within 5 years.
8. Nominated individuals/ organizations should not be convicted of a lawsuit under the Environmental Quality Act 1974 or other legal action within the nomination period.
9. The nomination must use the Nomination Form prescribed by the Department of Environment.

10. Nominated individuals must enclose a copy of the **identity card** with the **latest passport-sized photograph** while the nominated organizations, must attach a copy of the **certified organization registration document (except government agencies group)**.
11. Completed forms which comply to the nomination requirements, shall be addressed to the Secretariat of Langkawi Awards - Environmental Sustainability, Department of Environment (the address as below) before or at the closing date. Proof of post can't be used as proof of delivery.
12. The decision is final. The organizer reserves the right to withdraw the award if there are reasonable grounds for doing so.
