Dr Susan Baker is Senior Research Fellow in European Social Research at the University of Wales in Cardiff, UK. Her primary research interest is in environmental policy and politics at the EU level and she is currently engaged in a study of the implementation of sustainable development policies in a European context. Another research interest of hers is the gender-specific dimension of environmental policy. Her most recent publications include *Protecting the Periphery: Environmental Policy in Peripheral Regions of the European Union* (edited with K. Milton and S. As a former Dean and Pro-Vice-Chancellor of the Open University, Professor Blowers is currently Chairman of the Interfaculty Studies Board. He is also a member of the government's Radioactive Waste Management Advisory Committee (RWMAC), a former Vice-Chair of the Town and Country Planning Association and has served as an elected county councillor in Bedfordshire since 1973.

Dr Gerrit Faber is Associate Professor of International Economics at Utrecht University, The Netherlands. His main research interests are trade policy issues related to European integration and Third World development. He has published widely on these subjects. He is a member of the Dutch National Advisory Council on Development Co-operation.

Dr Pieter Glasbergen is Professor of Environmental Studies (Policy and Management) at both the University of Utrecht, The Netherlands, and the Dutch Open University. He specialises in planning and policy issues, with particular reference to environmental policy, physical planning, water management and landscape and nature conservation. His current research activities range from an examination of changing governmentbusiness relations with regard to environmental regulation to a study of the formation and development of the international regime for the regulation of the long-range transport of air pollutants (otherwise known as 'acid rain').
